Maria K. Chorianopoulou studied Philosophy at the National and Kapodistrian University of Athens (NKUA). She holds a Ph.D in Philosophy (NKUA) and currently is Assistant Profesor in the Department of Philosophy, (NKUA). Her philosophical interests fall within the wide realm of moral philosophy with particular emphasis on the emerging challenges met by Applied Ethics. More particularly, she focuses on rising concerns about human rights, genetic engineering, gene manipulation, intergenerational justice, environmental ethics etc. She has published articles in peer-reviewed philosophical journals and in memorial volumes compiled by the NKUA and the Democritus University of Thrace.
